Privacy Policy

Dreams InDeed International (“**Dreams InDeed**”, “**us**”, “**we**”) is strongly committed to protecting the privacy of our donors, website visitors and other individuals who communicate with us (“**you**”). This Privacy Policy (this “**Policy**”) applies when you make a donation to Dreams InDeed, whether online or otherwise, as well as when you visit our website, www.dreamsindeed.org/ (the “**Website**”) or share personally identifiable information (“**PII**”) with Dreams InDeed as discussed below. Dreams InDeed will use and disclose PII only in accordance with the terms of this Policy. For the avoidance of doubt, if you share information with Dreams InDeed pursuant to a contract with us, the terms of any confidentiality provisions in your contract apply.

FOR WEB USERS: Please read this Policy prior to submitting information to the Website. By visiting the Website and/or submitting information to the Website, you acknowledge that you accept the practices and policies set forth in this Policy and consent to having your data transferred to and/or processed in the United States. If you do not agree to this Policy, please do not use or submit information to the Website.

The Information We Collect

The type of information we collect varies depending on the nature of the activity and relationship with us.

1. **Browsing the Website.** When you browse the Website, we may collect information regarding the domain and host from which you access the internet, the internet protocol (“**IP**”) address of the computer or internet service provider you are using, and anonymous site statistical data. Our web server also utilizes “cookies” (small pieces of information that are stored by your browser on your computer’s hard drive) to track a user’s activity within our site as well as record the IP address of each visitor to this site. The foregoing information does not link to anything personally identifiable, nor do we disclose site usage by individual IP addresses. We use these IP addresses to help diagnose problems with our server and to administer our website, including determining which parts of our site are most heavily used so we can tailor site content to user needs.

Our information collection and disclosure practices will continue to apply as described in this Policy, regardless of any “Do Not Track” signals that are sent by certain browsers. But in general, Dreams InDeed does not collect PII about an individual’s online activities over time or across third-party websites or online services, and it does not permit others to do so other than as described in this Policy. You may refuse the setting of cookies by selecting the appropriate settings on your browser, including disabling all cookies from being set on that browser.

2. **Inquiries.** The Website contains forms, links to company e-mail addresses, and contact numbers that you may use you solicit information about Dreams InDeed. When you complete and submit a form, send us an e-mail, or contact us by telephone, Dreams InDeed may store the inquiries and their contents, including any PII you may have provided. Any PII you submit via an inquiry is collected only with your knowledge and active participation.
3. **Donations.** When you make a donation (whether online or otherwise), we will request certain PII about you to enable us to process your donation and communicate with you about it. Dreams InDeed maintains records of our donors’ names and contact information. If you make a donation through the

Website, Dreams InDeed does not store or otherwise maintain your payment information (*i.e.*, bank or credit card information). Donations, including information associated with your bank or credit card, are processed by Stripe, Inc, a leading provider of payment management services to hundreds of thousands of online businesses worldwide. All information associated with payments processed through Stripe, Inc will be handled in accordance with its Privacy Policy, which you may view here: <https://stripe.com/us/privacy>. When you make a donation through our Website, you agree to Stripe, Inc's Privacy Policy and Terms of Use (<https://stripe.com/us/legal>).

4. **Other Information.** Through our Website or otherwise, you may decide to submit PII for purposes other than donating (e.g. to receive newsletters or updates from us). We collect and store this information and use it for the purposes for which you submitted it. In addition, we may use such information to improve our communications and resource development efforts, keep you updated about our work, analyze usage of our Website, and improve the Website's content, layout and services. We do not share this information with any third parties except those that assist us with certain functions, as described above.

Use of Information

Dreams InDeed does not sell, rent, or provide access to our mailing lists, contact lists, or other stored PII to third parties, except as provided below:

- Dreams InDeed employs reputable companies to assist us with such functions as hosting our donor information database, sending postal mail and e-mail, and processing online and mail donations and credit card payments. These companies have access to PII as needed to perform their functions and adhere to industry standards for maintaining the confidentiality of customer information.
- Dreams InDeed may disclose any information, including, without limitation, PII, that we deem necessary, in our sole discretion and without your prior permission, to comply with any applicable law, regulation, legal process or governmental request.

Other Disclosures and Practices

- **Third Party Links.** The Website may contain links to third-party websites. Dreams InDeed cannot control and is not responsible for information collection practices of such websites, which may differ from this Policy. We encourage you to review and understand the privacy policies of those websites before providing any information to them.
- **Data Security.** Dreams InDeed maintains a variety of commercially reasonable safeguards designed to protect your PII from unauthorized access and disclosure. For example, we use industry-accepted tools and techniques to protect against unauthorized access to our systems and transmissions. You should be aware, however, that "perfect security" does not exist on the Internet. Third parties may unlawfully intercept or access transmissions or private communications.
- **Children.** This Website is not intended for persons under the age of 13. Dreams InDeed does not knowingly solicit or collect information from any person under the age of 13. If Dreams InDeed becomes aware that any person submitting information to the Website is under the age of 13, we will use our best efforts to remove such information from our files. If a parent or guardian becomes aware that a person under the age of 13 has provided such information to us, he or she should contact us at the address provided below.
- **Updating Your Information.** We work to process and accurately maintain the PII that you share with us. If you have donated to Dreams InDeed and would like to correct or update your personal data or to adjust your mail preferences, you can do so by contacting us at the address provided below.

- ***Changes to this Policy.*** We may occasionally update this Policy to reflect changes in our practices. When we post changes to this Policy, we will revise the updated date at the top of the Policy. If we make any material changes to our Policy, we will notify you by prominently posting notice of the changes on the Website. We recommend that you check the Website from time to time to inform yourself of any changes in this Policy or any of our other policies.

By using this Website, you consent to your information being transferred to our facilities and to the facilities of those third parties with whom we share it as described in this Privacy Policy.
- ***No Rights of Third Parties.*** This Privacy Policy does not create rights enforceable by third parties.
